KI/TRR Lawsuit:

The Board continues to protect your investment interests against Steed and his companies. This summer the Board presented a proposed solution to all outstanding issues and offered several days over the summer as options for the Board and its attorneys to meet with Steed and his attorneys to discuss a settlement. Once again, Steed did not agree to a meeting, nor did he respond in any way. As a result, the Board has taken additional legal action while keeping our initial lawsuit in place.

The Board is committed to continue to represent all owners' best interests. We will provide additional information and answer any questions at the annual meeting on November 2.

Siding Project & Other Maintenance Projects:

The Siding & Railing Project is now completed. Our thanks to Tri-Lakes Exteriors for their workmanship and follow up on this project.

Other scheduled maintenance projects include:

- East side stairs from parking lot level to 2nd floor to be repaired and stabilized
 This area has been closed until the repairs are completed
- Roofing on Bridge View building to prevent water backing up into soffits
- Lift Station repairs

Grease Disposal:

Grease from cooking should not be disposed of in the drains. Grease is harmful to the waste water pipes and creates especially expensive Lift Station repairs that the association maintains. Please dispose of all cooking grease in a can until hardened and then throw away in the trash.

Among those are to never put grease down your drain, how to combat smelly water, the use of Covered Propane Grills only, and insurance information.
