## KI/TRR Lawsuit:

The Board continues to protect your investment interests at Anchor's Point. The Board is committed to continue to represent all owners' best interests. We will provide additional information and answer questions at the annual meeting on October 3rd.

## Grass Mowing (Updated):

Since our Owners Update of August 29<sup>th</sup>, the Corps of Engineers has approved the revisions to the Table Rock Lake Shoreline Management Plan. The required changes which will allow Anchor's Point to cut the grass were included in the approved plan.

The Board has submitted an application to obtain a Vegetation Permit which would allow the association to once again cut the grass. We have been in contact with our local CoE Ranger and awaiting a required walk through and the issuance of our permit.

## **Flood Plain Determination:**

As many of you know and some have experienced in July 2019 a new FEMA Letter of Map Amendment Determination Document identified Anchor's Point units 400 – 464 in a Flood Zone A. This Zone A determination makes loan approvals difficult without Flood Insurance. The board has been working with an engineering company to find out how this determination could have changed 29 years after construction and 9 years after the 2010 Flood Determination which is the determination posted on our website. Although we have not been able to determine who or why a new Flood Determination was made, but the engineering firm has recommended a couple of resolutions which we are addressing. We will be providing additional information at the annual meeting.

#### **Owners Lakeside Pool Party:**

The Anchor's Point Owners Lakeside Pool Party was held on September 13<sup>th</sup>. Thanks to Ashley Services for hosting the event and for a great summer at the pool. Although attendance was lower this year due to COVID-19, it was still great to see friends and to meet new owners. The food was fantastic and the gathering was quite successful.
