Board of Managers Election:

According to the APCOA by-laws, there are three members serving on the APCOA Board of Managers and one manager is elected each year for a 3 year term. There are currently 2 Manager positions available. Jim Heimann's term expires in 2021 and Ray Loehr is currently an Acting Manager. Any eligible owner may submit a Candidate Application. Each Candidate Application will be copied and distributed to the membership and each owner is allowed one vote for each unit owned.

The election schedule is:

- Board of Manager Candidate Applications is available for downloading on the APCOA website or may • be requested from the association at any time.
- Manager Applications must be submitted by candidates on or before August 1, 2021. •
- Each candidate application, a ballot, and a return envelop will be mailed to each owner for each unit • with the Pre-Meeting Packet prior to the Annual Owners Meeting.
- Ballots must be received prior to the start of the Annual Meeting on October 2, 2021. •
- Election results will be announced at the Annual Meeting on October 2nd. •
- The elected candidate will assume the office at the end of the Annual APCOA Meeting. •

The Board knows this claim has no merit whatsoever; however, the Board will continue to battle to protect your investment in your property.

Cameras:

Most owners are aware that the Dumpster and Parking Lot are continuing problems that need to be addressed. We have recently met with the Kimberling City Police to see what steps might be taken to address unauthorized dumping in our dumpsters and trailer parking in our parking lot.

The KC Police suggest that they want to cooperate and make the city a better place and there are things the association needs to do to assist them. That assistance comes in the form of parking lot cameras and proper informative signage with one of the focus points on the dumpsters.

The Board is currently investigating the options and cost of placing cameras on the parking lot and Lakeside Pool area. The Board is also sensitive to privacy issues of owners and guests. Any camera system would be set so that no camera view would include any unit deck.

As we study the system(s), we welcome your comments and concerns.

Anchor's Point Water System:

Our water system has been fully operational since May 4th and the system has performed as expected. However, with the startup of a new water system, one can expect some VERY FINE rock particles from the drilling process (similar to sawdust if sawing wood). There is no danger from the particles but over time they will clog up your filter and faucet aerators. We recommend that you change your filter if you haven't already. Depending on water usage, you may need to change it again in another month. Additionally, you may see some spurts of brown water. That's to be expected for a time. Here's why: We

now run the water to your unit at 1.2 ppm of chlorine, but in order to ensure sanitization of the new system, we started up at 2.5 ppm (some of you may have noticed a strong chlorine smell for the first couple of weeks). We now know that the heavier chlorine concentration actually "broke loose" some sediment in the 28-year-old pipes in the complex. Some of that old stuff is finding its way to your filter and clogging it earlier than usual, and some of the really fine particles may create a brown tint to your water. Of course, we sample regularly and there are no dangerous bacteria in the water. Additionally, the chlorine concentration is sampled every 30 seconds and adjusted automatically.

The water system compliance notice required by the DNR is on the APCOA website under the "Services" tab.
